Cleveland County Sheriff Joseph K. Lester created the Cleveland County Top 10 Most Wanted program upon taking office in January of 2009. This program is worked jointly with the U.S. Marshal's Metro Fugitive Squad in Oklahoma City and a Cleveland County Deputy assigned to the Metro Fugitive Squad. The Deputy works specifically with the U.S.M.S. to track down fugitives who are attempting to escape justice and arrest them. An assessment is completed on outstanding felony warrants and top suspects are selected based on the type & nature of the crimes committed, and the potential for further criminal acts these suspects may pose to residents of Cleveland County if they are not apprehended. Since the inception of this program, numerous Top 10 Most Wanted suspects have been apprehended in Oklahoma and other various states based off tips from the public and proactive law enforcement work.
